Deposition of John Richardson of Dorchester County, aged about 58 years, mentions John Nicols Senr. (now deceased), about 25-26 years ago. Also mentions John Nicolls Junr., deceased.

Deposition of Thomas Andrew of said county, aged about 61 years, mentions John Nicolls (now deceased), about 12-13 years ago.

Deposition of Peter Edmondson of said county, aged about 65 years mentions Edward Hardikin (now deceased), about 20 years ago.
