The affirmation of Mrs. Sarah Kennerly of Dorchester County, widow, a Quaker, concerning her knowledge of Isaac Lee late of Dorchester County, shoemaker, deceased, who lived on a plantation near Wm. Jones's and died about October 1766, states that she always understood that the said Isaac Lee came to this Province a convict for 14 years and that he came to the Province as near as she can remember, about 33 years ago; that her late husband William Kennerly bought the said Isaac Lee, as a convict servant for 14 years; that she thinks he bought him from Mr. James Edge who formerly kept store for Mr. James Gildert, Mcht.; that the said Isaac Lee served her said husband for six years before being set free, and that she understood the said Isaac Lee was convicted for stealing horses.

Deposition of William Richardson the Elder of Dorchester County, aged about 64 years, re bounder of Wimple's land, or land called "Providence".

Deposition of Benoni Frazier of Dorchester County, aged in his 78th year, re conversation about 47 years ago with Thomas Barnett, then of said county, about a tract of land belonging to Thomas Richardson, then of Talbot County, states that the said Barnett told him that he was present at the survey of "Providence" and that a post was set down on the bank of the river, at the mouth of Indian Creek.

Affirmation of James Wilson of Talbot County, aged in his 78th year, re bounds of "Providence", mentions Thomas Barnett who showed him a bounded tree of said land on Hollands Creek, about 46 years ago.

Affirmation of William Wilson of Talbot County, aged about 68 years, a Quaker, re bounder of "Providence" shown to him about 35 years ago by Henry Ennalls (son of Henry Ennalls), late surveyor of Dorchester County.

Deposition of William Rumbold of Dorchester County, aged about 47 years, re bounds of "Brotherly Kindness", mentions William Brown Vickers who was drowned and was buried near the root of an oak tree said by John Harris to have been the bounded tree of a tract of land.

Deposition of John Harris of Dorchester County, aged about 56 years, re bounds of "Brotherly Kindness" mentions James Willson, William Willson, Joseph Willson and Thomas Willson, who were all brothers, "who had been runing the afsd land" about the year 1743. This deposition taken in the presence of Revd. Philip Walker, James Willson, Wm. Willson and Stephen Fleharty, person concerned, and sundry other persons.

Certification locates bounder on the bank of Great Choptank River, about 150 - 200 yds. below the landing "called Harris's Landing but now Walkers Landing"; and a bounder on Great Choptank River nearly opposite the mouth of Kings Creek, about 300 - 400 yds. above Walkers Landing.

Deposition of James Shaw of Dorchester County, aged about 25 years, re the Locatia Path, an Indian Path shown to deponent in 1769 by Solomon Wright, deceased, leading from the main road to Cratchers Ferry, near a plantation where Andrew Lord then lived, to the plantation where Henry Ennalls now lives. Taken in the presence of John Pitt Airy, John Wallice, William Hutton and Theophilus Hackett.

Deposition of William Hutton of said county, aged about 38 years, mentions Thomas Ennalls, Henry Ennalls, Wm. Williams and Maj. Ennalls' land at a survey about 9 or 10 years ago. Also mentions "Thomas Hackett the Elder who lived the other side the Fork now deceased".

Deposition of William Eccleston of said county, aged about 36 years, mentions Solomon Wright (now deceased), about 2 years ago.

Deposition of Roseanna Williams of the same county, aged about 50 years, mentions her father Oliver Hackett deceased and her uncle Thomas Hackett the Elder, deceased, and a path that they showed her about 30 years ago, on the road from the Northwest Fork Bridge to Vienna, near land where Moses Lord formerly lived, sometimes called Patricks Path and sometimes Cliftons Path. Also mentions Wm. McCollister, about 20 years ago; and deponent's grandfather Thomas Hackett.
