At present the Daniel Family Cemetery, of which most of us are descended is in great danger. This cemetery has been greatly desecrated, and left for the final blow of being no more. This cemetery contains those of our beginning in Brunswick County, which include the descendants of both, the Joseph Daniel and the Peter Daniel Families, and include their family descendants down to the early 1900's such as Andrew Daniel and Wesley Daniel Family's.

There is a suit in the circut court of Brunswick County, between H. W. Daniel, acting in defense of, as plaintiff for the Daniel Family of the Daniel Cemetery, vs the Barrow Family, the heirs to the property, heir deed which has reservations to the said cemetery, and Hawthorne the Cutter of the timber for the Barrow Family, and in which the damage was done to the cemetery at this time of cutting the timber. The time of timber trial court is November 1996, at the Brunswick County Circuit Court.

It is my request that you, and all the Daniel Family, as well as those interested in the historical, geneological, landmarks, etc. of the County of Brunswick, and the family's therefore, be present at this case to be held, and the family's therefore, be present at this with your presence, advice, moral support, and testimony or assistance in presenting the case if possible. Your support and aid will be greatly appreciated, by all the descendants for many generations to come, as they will reep the harvest from that which we sow.

You are the recipients and heirs to this family cemetery by deed. You can protect your rights by law. You can save this cemetery, and all the benefits for which it represents. PLEASE DO NOT THROW IT AWAY. PLEASE SUPPORT THE CAUSE.

CEMETARY BEING 1/2 NILE SOUTH ON 617 then 120 YARDS EAST THROUGH WHAT WAS WOODED LAND AND ACROSS THE BRANCH, WHICH IS 50 YARDS OFF EAST OF STATE RT. 617. IN THIS DANIEL CEMETARY, AND A SON OF JOSEPH DANIEL JR. B- /1760 D-2/27/1832, AND HIS WIFE SALLIE CORDLE DANIEL B /1770-D-E/ER/1860 PLUS YEARS, A LIFETIME RESIDENT OF DANIELTOWN, BRUNSWICK, VIRGINIA, WHO IS ALSO BURRIED HERE, ALONG WITH MOST OF THEIR CHILDREN, ALSO THE SON OF JOSEPH DANIEL SR -B- -D-1/12/1793AND HIS WIFE HAVING RECIEVED DANIEL B A LAND GRANT OF WHICH THIS WAS A RART, AND BURRIED ALONG WITH SOME OF THEIR MILDRED (MARY) NELSON CHILDREN IN THIS CEMETARY, AND WERE RESIDENTS OF BRUNSWICK, VIRGINIA, MARRIED A DREWRY. AND THE SON OF JAMES DANIEL B Dura OR ELIZABETH WILLS (ACCORDING TO OLD INFORMATION), AND IS BELIEVED, THAT THE JAMES DANIEL IS THE BEGINNING OF THIS DANIEL FAMILY CEMETARY, WHICH IS IN QUESTION TODAY AS TO DAMAGES.

THIS CEMETARY LEFE THE JOSEPH DANIEL BY MEANS THAT ONE OF JOSEPH DANIEL'S DOUGHTERS, MARRIED A PETER DANIEL, WHICH IS BURRIED IN THE NOETH END AND WAS THEIRIN FENCED, AND THE LAND PASSED ON DOWN THROUGH THE PETER FANIEL FAMILY UNTIL THEIR DESENDANT WESTLEY DANIEL, SOLD TO W. H. BARROW BY DEED IN 1881, as stated in deed book 46 - page 132, and in which their is reservations to 1/2 aces to be used by other family members. THE TWO JOSEPH DANIEL FAMILYS ARE BURRIED IN THE WEST CENTRAL PART OF THIS CEMETARY, AND THE ANDREW DANIEL FAMILY IS BURRIED IN THE SOUTH EASTERN BORTION.

BY NOTATION IN 1948 WHILE WITH CARTER JONES DANIEL, BOTH BEING PRESENT AND OF SOUND MINE, WHILE ON ONE OF OUR REGULAR VISITS, AND AT HIS DIRECTION WE MADE A DRAWING OF THE GENETARY, AND ITS LOCATION IN REFERENCE TO THE CHANGED ROADS AND POWER LINES AND BRIDGES, ENC., AND BY USING MARKED TREES, BRANCH, AND POSIBLE OLD SPRING HOLE, ENC, I SQUARED EACH GRAVE, AND PLACED A NAME THEIR IN, AS I WAS TOLD BY CARTER JONES DANIED WHOSE PARENT AND BROTHERS AND SISTERS WERE BURRIED THEIRIN. THIS CEMETARY CONTAIN 3 ROWS OF FAMILY GRAVES, AND POSSIBLY, 30 GRAVES EACH ROW. THIS CANNOT BE RECOGNIZED AS SUCH SINCE THE

DESECRATION.


