

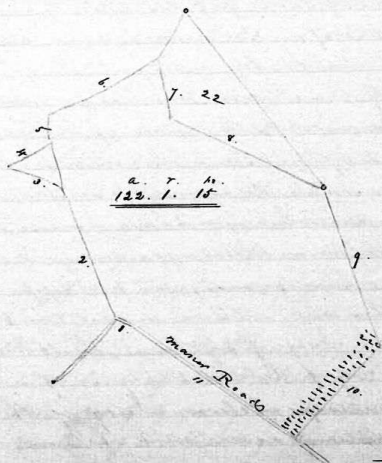

State of Maryland, Frederick County, to wit - I hereby certify - that I have carefully surveyed, and Calculated Mrs. Caroline Cromwells land, and find the same to be part of a Tract of Land Called Good Luck part of Lot N^o 6. which is part of a Tract of Land Called "The addition to Carratten" and part of Richards Amendment - Beginning to include the whole in one general outline at a Stone where formerly stood a large white Oak tree, it being the Beginning of the aforesaid tract, called "Good Luck" it being also at the end of the 37th line of said Lot N^o 6. one of the divisions of Carratten Manor, and at the Beginning of the deed from Catharine Harpur to Richard Cromwell dated the 7th June 1833 for 1. 3^{rs}. 6^{ths} and running thence, with said Deed reversed, correcting the closing line viz. N 18 1/2° E 7 1/2 ps to the end of the 30th line of Lot N^o 6. aforesaid it being in the public Road, thence with the out lines of said Lot N^o 6. three Courses reversed, and the public Road N 65° E. 70 ps to a stone then leaving said Road, Still N 24 1/2° E. 36 ps. to a stone S 30 1/2° E. 27 1/2 ps. to a stone in the middle of said Public Road, at the end of the fourth line of the aforesaid tract called Richards Amendment, thence by and with the out lines thereof 2 Courses, and the said Road N 76° E. 14 1/2 ps. to a stone S. 29 1/2° E. 65 1/2 ps. to a stone at the end of 47 1/2 ps. on the 25th line of the addition to Carratten, it being at the Beginning of the deed from Catharine Harpur to Richard Cromwell, dated 10th Decr 1839 for 22. 1st. 11th thence by and with the closing line reversed of said Deed S 71° 10 3/4 ps. to a stone at the end of the 2^d line of the aforesaid tract called "Good Luck" it being at the end of the 39th line of Lot N^o 6. aforesaid and with the out lines thereof. S 21 1/2° W. 88 ps. to a stone S 66 1/2° W. 87 1/2 ps. to a stone N 81 1/2° W. 70 ps. to a stone at the end of the 3^d line of said Lot N^o 6. & with the 37th line thereof Correcting the same N 85 1/4° E. 107 1/4 ps. to the place of Beginning - Containing 122. 1st. 15 ps. S. H. P. Real. Surv. F. Co. Feb. 14th 1855.
