THE GREAT STRIKE.

The strike of railroad employes, first inaugurated on the Baltimore & Ohio and since extended to most of the roads east of St. Louis and Chicago, has resulted in riot, bloodshed and anarchy, and scenes rivaling the excesses of the Paris Commune have been enacted at Pittsburg. These proceedings are a disgrace and foul blot upon the American name, and are deeply deplored by every patriotic citizen, but they are chargeable directly to the railroad autocrats who have for years defied all laws, all rights, all authority, all sense of justice and all claims of the people who gave them the wealth and power they have so oppressively used.

The railroad magnates have robbed their stockholders of millions every year by high salaries for themselves and a horde of relatives, the organization of fast freight lines for private gain, the corrupt letting of all contracts to themselves, and the general practice of credit mobelie crookedness; and then, in spite of all these leeching processes the road earned large dividends, the stock was watered and the people further oppressed to keep up all the stealings and pay fair dividends on the new stock.

Occasionally, however, these kings have engaged in war and reduced the princely income of their roads, or a period of depression in trade has overtaken them, and then instead of lessening their official salaries or stealing they announced an arbitrary reduction of ten per cent. in the wages of their poorly paid employes. If this reduction was submitted to, and competition or hard times continued, another reduction was made the following month. This course of proceeding, long continued, has at last produced the horrors committed by frenzied men demanding food for their families.

The carnival of blood and fire seems to have been precipitated by the too hasty firing of the militia upon the people. The mob were maddened by the sight of their dead and wounded comrades and swore vengeance over their mangled bodies. The sympathies of all classes of people were with the strikers and their ranks were recruited from all trades, and so long as the rioters did not threaten the destruction of the city the people of Pittsburg did not organize in sufficient force to suppress lawless proceedings.

The loss of property has been enormous at Pittsburg, estimated at three to five million dollars—enough to pay the difference in wages demanded for years and years. There has been some destruction of property at Reading. These losses will fall upon the State of Pennsylvania or the counties in which they occurred, but it hardly seems right that they should. All established governments undertake the protection of the property of the citizens. The railroad companies of course will demand reimbursement of all losses. The loss of life has been considerable, but the aggregate cannot yet be ascertained.

The U. S. Circuit Court, it will be remembered, recently gave judgment in favor of Myra Clark Gaines as the legitimate heir of Daniel Clark and the rightful owner of his immense estate in New Orleans. The time within which an appeal could be taken from this decision having expired, and no notice of appeal having been made by any of the present owners of the property, it is inferred that they have abandoned the contest of forty years and will now proceed to make the best terms they can with Mrs. Gaines.

There was no bullion produced by the Yellow Jacket mine during the last fiscal year. The receipts were \$403,359, including 300,000 from three assessments. All the above was expended, leaving overdrafts to the amount of \$34,939 unpaid at the close of the fiscal year ending July 1, 1877. Of the disbursements, \$118,178 was for account of the new shaft, which is now down 800 feet, timbered throughout with 14 x 14 inch timber, five feet two inches from centres.

A German Polian company of colonists has purchased 50,000 acres of land in Arkansas.

THE IDAHO WAR.

The Indian war in Idaho seems to have been brought to a sudden close for want of a foe. The hostiles have taken themselves out of that Territory into Montana, with the evident intention of escaping to the northern wilds where no troops will follow them. A dispatch dated Helena, July 23d, says: "Advices from Missoula to 1 A. M., of the 21st, report eighteen lodges of hostiles in the valley, having come over the Lolo trail from Idaho. The Indians are coming in fast. All the settlers are moving into stockades. The Indians appear to be trying to escape through the upper end of Bitter Root into the Big Horn country. There is no doubt that they belong to Joseph's band. The mail rider says it is reported that quite a number of the Indians are wounded. A company of soldiers left Fort Ellis for Missoula yesterday. Others will follow from other posts as speedily as possible."

The New York Sun publishes some facts connected with Horace Greeley's last days on earth which have never before been printed. It says that the blow which prostrated Mr. Greeley and led to his death was the exclusion from his old post of editor of The Tribune. After having given notice through The Tribune of the 7th of November of his resumption of its editorship, he was misrepresented and abused in the columns of his own paper, and attempted in vain for three days to have a correction inserted. It then became evident to him that he had been deposed from the control of The Tribune, and he was shortly after conveyed to a private insane asylum, though this fact was contradicted by The Tribune. The Sun says: "For the first time Mr. Greeley felt that he was utterly helpless. He bowed his head in misery and despair, wearily wended his way to his desolate home, and steadily sank into insanity and death." Almost his last coherent words were: "The country is gone, The Tribune is gone and I am gone." According to late accounts The Tribune has not prospered under the men who cheated poor Horace Greeley out of the control of the great journal which he founded, and whose name they warily placed at the head of its columns.

WHAT we receive from Russia and Turkey is of small consequence. From Russia we obtain wool, rags, flax, cordage and iron; wool and iron are the principal articles, and these are in good supply in the London and home markets. From Turkey we buy some rather important drugs and prunes. The value of the imports is about two millions, while our exports amount to nearly sixteen millions, of which eleven and a half are to Russia. The exports consist of cotton and petroleum, the former being the more valuable. Nearly ten million gallons of petroleum are thus disposed of. Russia and Turkey contribute largely to feeding the rest of Europe, and as the war will interrupt agricultural pursuits the supplies in this country will be freely drawn upon should the war last any length of time.

THE New York Journal of Commerce objects to any further contributions by the Government to expeditions to the North Pole contending that the record of all recent expeditions will corroborate the conclusion to which the most experienced Arctic navigators have now arrived—that the obstacles between latitude 83 degrees and the pole are practically insuperable, and that to fight against them longer is foolhardy and useless.

A FINAL decision in the famous Jumel case confirms the title of the present occupant of the estate, William L. Chase, the son of Mme. Jumel's niece, and finally dismisses the claims of Bowen, who has been striving for so many years to set aside Mme. Jumel's will, claiming to be her son, born out of wedlock before marriage with Jumel.

THE San Francisco Chronicle rejoices in another victory over Sargent and Page. The Alameda Grand Jury, which had the matter under consideration the other day, quietly ignored the indictment asked for by these gentlemen.

A FIRE in the Lick House, San Francisco, Sunday, completely destroyed the elegant dining room of the hotel. No other damage was done.

Telegraphic Paragraphs.

The railroad strike has extended to most all the roads east of the Missouri river. Many of the short roads have acceded to the demands of their employes, but none of the trunk lines have yet done so.

Saturday night and Sunday a mob destroyed several millions' worth of railroad property, and many lives were lost in collisions with the troops, in Pittsburg.

Considerable property has been burned at Reading, and thirty-seven lives lost.

At Buffalo several lives were lost in the strike riots.

Six powder mills exploded at Acton, Massachusetts, yesterday.

Governor Hartranft has returned to Pennsylvania.

President Hayes is in favor of vigorous measures to suppress the riots, and he issued a proclamation yesterday commanding the rioters to disperse.

Captain Crapo reached Cornwall, England, with his little schooner, Saturday night.

The garrison at Malta is being reinforced, and the war feeling is increasing daily in England.

Sharp fighting is reported before Rostchuk.

Russia is said to maintain a defiant attitude toward England.

A workmen's meeting in San Francisco Monday night ended with some depredations on the Chinese, but the police quelled the incipient riot.

EXPENSIVE funerals have been checked by a Pennsylvania probate court. A worthy citizen had died and had been buried "in style;" on the settlement of the estate it was found that the personal property of the deceased amounted in all to \$581 82, against which the administrator had charged \$139 75, or about one-fourth of the whole, for the expenses of burial. The Judge very promptly and very properly refused to allow any such charge, declaring that "pompous processions of great length, glistening silver-plated caskets and carved marble monuments are unnecessary for Christian burial." Such parades as are called "fine funerals," the Judge continues, may gratify the vanity of the living. "But no respect for the dead demands them, and when a decedent's estate is limited and his debts are not paid, or where he leaves a family of helpless children, the expenses of such burials will not be allowed out of his estate. Those who contract for and enjoy such luxuries must pay for them themselves."

THE Railway Age favors a slightly increased rate of speed on the overland railroad. At present the time spent by the express from Omaha to San Francisco is something over 102 hours for the 1,916 miles, or an average of a little over nineteen miles an hour. If the speed were increased to an average of twenty-five miles, the long journey would be reduced fully twenty-four hours—a very important saving to travelers on business, and one that would not be at all unwelcome to pleasure tourists.

AS THE time approaches for holding the elections in France the determination of the Government to secure the return of its own candidates at all hazards, becomes more manifest. Republican journals are prosecuted on the flimsiest pretenses, and the editors fined and imprisoned. On so slight a charge as that of publishing accounts of the trials of Republican journalists, one paper in Marseilles was lately suspended. Most of the Government candidates are Bonapartists, and all are of Monarchical tendencies.

CHIEF JUSTICE WAITE has written a letter to ex-Governor Aiken of South Carolina, indignantly denying the statement which has gone the rounds of the papers, to the effect that he was not treated with courtesy by the people of Charleston when there recently. He denies ever having said a word from which such an inference could possibly be drawn, and says that he had no such thought to his heart.

GOSSIPS say there will be a grand wedding at the Silver House at an early day, but the young ladies preserve so much mystery about the happy event that our reporter is unable to learn whether the bride will be a blonde or a brunette.

STATE NEWS.

The next term of the State University will begin August 3d.

The thermometer marked 106 deg. in the shade, in Elko last Wednesday.

A German named W. Heinrich died at Austin, July 20, from the effects of a sun stroke.

The Paymaster mine is looking better and producing richer ore than ever.

Belleville, Esmeralda county, had a \$20,000 fire recently. The best part of the little town was consumed.

The Supreme Court has granted a supersedeas in the case of Rover. This postpones his execution until argument for a new trial can be heard.

The trial of the suit between the Eureka Consolidated and Richmond mining companies is progressing in the United States Circuit Court, San Francisco.

Sam Mills, the negro who killed Jimmy Finerty at Halleck's station, has been convicted in Elko of murder in the first degree. Of course he'll hang.

The two furnaces at the Enreka Consolidated turned out on Friday last 500 bars of bullion for the twenty-four hours' run, aggregating about twenty-eight tons.

A Tybo boy was kicked in the mouth by a cow in the upper part of town last week, while in the act of twisting her tail. The cow is doing well and the boy is improving.

A spring of water has been discovered on the northern slope of Eureka mountain, distant two and a half miles direct, and three miles by pipe from Eureka. From four to six inches of water can be had at all times.

The Convis and DeFrees mining companies have filed the necessary papers in the County Clerk's office, preparatory to instituting suits in the District Court against the Grand Prize Company's title to that mining property.

Four men in Oseola district took out six ounces of pure gold dust during one day last week. To do this they were compelled to purchase water at the rate of two cents per gallon, and they used 160 gallons.

The twenty-sixth consecutive monthly dividend of the Northern Belle mine was paid Thursday. No mine off the Comstock lode, and very few of the Comstock mines, have paid as many dividends in as many months.

Many, it not all, of the disreputable characters who have infested Winnemucca and depended upon their ability to steal for support have hurriedly left town. Many of them, we understand, says the Silver State, were personally notified to leave, and those who were not took the hint from their associates and silently stole away.

In spite of all the bravado by Mexicans, the order to chase thieves into that country has worked well, the Mexicans having taken steps to prevent riots in the future. As they believe that President Hayes means what he has said, it is probable that there will be no necessity to resort to what has been termed international lynch law, which circumstances have heretofore amply justified.

SIX universities in Germany have more than one thousand students each. Leipzig and Berlin take the lead, having respectively 2,730 and 1,977. In the twenty-one universities of the country there are now 17,143 students and 1,827 teachers. The number of Protestant theological students is as follows: Leipsic, 338; Tubingen, 260; Halle, 190; Erlangen, 196; Rostock, 24; Heidelberg, 9.

EVERY time the Turks meet with a reverse a general removal of officers ensues. Very much like the system which prevailed in our army during the war of secession. Had a single serious setback occurred to Grant in the earlier part of his career, that career would have come to a sudden end.

GERMANY, it seems, has become alarmed at the condition of her general trade and manufacturing industries. At a recent convention on the subject a sort of Chinese policy was recommended—namely, to make no more commercial treaties and put up the tariff.

RUNK, the hoodlum who murdered Silver Coots in San Francisco, will be sentenced on Friday.
