October 16, 1913 Luther Edwin HUFFMAN died October 15. He was age 70 years, 5 months and 9 days old. He came here from Texas where he had lived some 34 years, having gone out west from Tennessee, but his birth was near Charleston, South Carolina. He served in the Confederate Army. He married Miss Catherine GARY and he is survived by her and three sons and five daughters.
