In November of 1881, Henry C. Roberts' property was sold at public auction by the court to pay his debts and what monies that were left was to be divided among his heirs as outlined by his last will and testament. William Brown Roberts, the eldest son, was appointed administrator of the estate and was responsible to the court for the actions of seeing that the will was carried out as was outlined by the Inferior Probate Court.

In February of 1882, Lucinda Roberts petitioned the Inferior Court Judge of Decatur County, stating that the late Henry C. Roberts had not made any provisions in his will for the support of his widow and three minor children by a previous marriage because of the unusual nature of of his unexpected death. Monies and provisions were then set aside by the court for their care and maintenance.

In May of 1882, a wagon train was leaving Bainbridge for south Florida. William Brown Roberts, eldest son of Henry Roberts heard about this wagon train and he and the Albert J. Cordell family began to make preparations to travel in that train to south Florida.

The tragic death of Henry C. Roberts on Feb. 18, 1881 caused a chain of events that would bring pioneers to a new unexplored area of south Florida. Also those close relatives left behind in south Georgia would have additional responsibilities placed upon them.

Mrs. Lucinda Roberts lived several years in Iron City, Georgia with her relatives and then in later years over in Donalsonville, Ga. where she died in 1926.
