Edmund and Temperance were two of the eight organizers of
the Hebron Primitive Baptist Church in Hamilton County on Feb.
20, 1858. He was shown as Church Trustee on March 20, 1858 and
as a licensed preacher on Sept. 7, 1860. They were dismissed
by letter on Dec. 10, 1864.

They moved to south Florida settling first near Pine Level and later in the Duette area of Manatee County. They were listed there in the 1870 census along with Berry Keen, Jacob Keen and Herod Keen. The minutes of the 1870 annual session of the South Florida Baptist Association listed Edmund as a licensed minister of the association with his post office at Alafia. In 1872 he was a delegate to the association from Benevolence Church in Manatee County. He is shown as the pastor of that church in 1873 and in 1875 as pastor of Mt. Pisgah Church.
